THE LOT IS COMPLETED AND READY TO BE RE-OPENED FOR TRAFFIC BY
CONTACTOR. AGAIN, PLEASE BE REMINDED TO

REMOVE ALL VEHICLES NO LATER THAN 6:30 AM
